Importance of Agreements

- #1 Business Success Principle in Operations:
 Have Great Agreements
- Especially between friends!
- Have every "significant" contract reviewed by an attorney
- Work out the business terms first, then have an attorney work out the "legalese"
- Make sure the agreements are signed and filed where you can find them!



Inner Issues about Attorneys

- Don't understand the language, and afraid of being taken advantage of
- Don't want to spend the money
 - Attorneys charge from \$300 to \$1,000 / hr
- "A stitch in time saves nine"
- Used proactively, they are like insurance policies


