## Example

- We decide to have a series of workshops together

# Example

- How do we fund the venture?
- Will we set up a new company?
- Who will schedule, pay for the venues?
- How will people sign up?
- Who will take the money?
- When will we get square with each other?
- When will we end the new company?

## **The Bottom Line**

- There are a lot of things to consider when establishing a Joint Venture
- Thinking it through will save you a lot of money and time, and perhaps a lot of grief
- Get a coach to help craft the relationship, and an attorney to review agreements and form a new company if necessary




